Conflict Minerals Rule Requires Detailed Annual Reporting

Section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act requires companies reporting to the Securities and Exchange Commission (SEC) to declare the origin of Conflict Minerals (tin, tantalum, tungsten and gold) in their products. Even if your company is not publicly-traded, you will likely get requests from your customers to comply.
