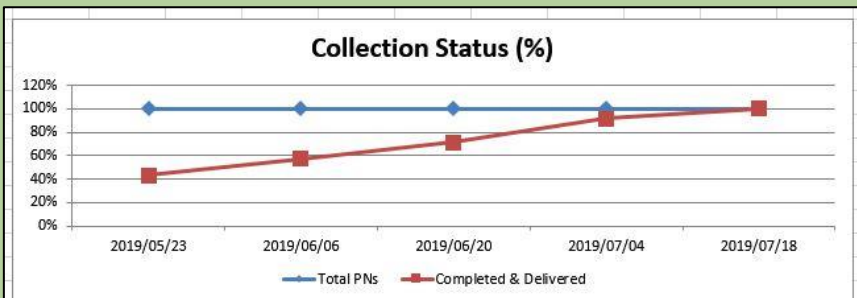


## How it Works

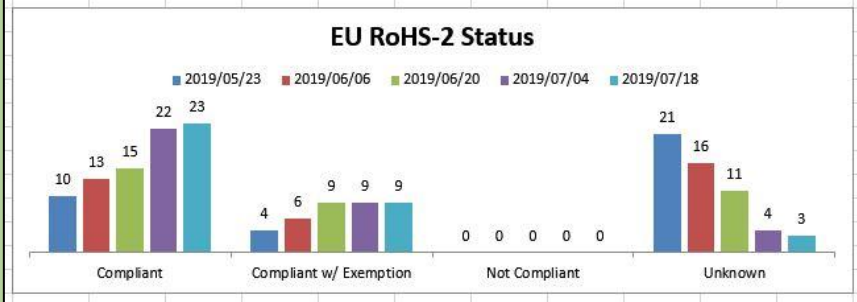

### Sample BOM Grand Report
